Dear Mr Giordimaina,

**Re.: Enforcement order issued by the Malta Resources Authority under L.N. 525 of 2004 to the Water Services Corporation with regard to licensing obligations**

Reference is made to the licence issued to the Water Services Corporation (hereinafter 'WSC') for the supply of water through the public water distribution network and for the provision of sewerage services using the public sewerage collection system and to several previous communications on the subject.

Notwithstanding that the Authority has in several occasions granted further extensions to the timeframes established in the aforementioned license, to date the WSC has not carried out the required actions, nor has the Authority received from WSC any submissions or information as to the actions required to be done by WSC in terms of the licence. These are reproduced below for ease of reference with the relative (expired) deadlines:
