IN accordance with the provisions of paragraph 9 of Government Notice No. 203, SCHEME A – Electric-powered Cars, published in the Government Gazette dated 1st March 2005, and in accordance with the provisions of Government Notice No. 82, which was published in the Government Gazette of the 28th January 2008, the Minister for Resources and Rural Affairs, with the concurrence of the Minister of Finance, the Economy and Investment, is hereby amending paragraph 5 of Government Notice No. 203, referred to above, as follows:

1. Biex il-Gvern ikompli jinkoraġġixxi aktar l-użu ta' karozzi li jahdmu bl-elettriku għall-użu personali, il-Ministru għar-Riżorsi u l-Affarijiet Rurali, bi qbil mal-Ministru tal-Finanzi, l-Ekonomija u Investiment, qed jgħolli r-rifużjoni fuq dawn il-karozzi għal 20% tal-valur tax-xiri tal-karozza sa massimu ta' elfejn, tliet mija u disgħa u għoxrin Euro (€2,329). Dan it-tibdil fuq ir-rifużjoni japplika biss fuq dawk il-karozzi li jahdmu bl-elettriku li jkunu ntraw fl-1 ta' Jannar 2008, jew wara.

1. In order to further encourage the use of electric-powered cars for personal use, the Minister for Resources and Rural Affairs, with the concurrence of the Minister of Finance, the Economy and Investment, is increasing the grant to 20% of the purchase price of the car, subject to a maximum of two thousand, three hundred and twenty-nine Euro (€2,329). This increase in the grant applies only to those electric-powered cars purchased on the 1st January 2008, or afterwards.

2. In such cases, applications shall be submitted within three months from the date of publication of this Notice.
