*Amendment to the Scheme*

SKONT is-sezzjoni 7 tan-Notifikazzjoni tal-Gvern Nru. 200, ippubblikata fil-Gazzetta tal-Gvern tal-11 ta' Marzu, 2009, il-Ministru għar-Riżorsi u Affarijiet Rurali, wara konsultazzjoni mal-Ministru tal-Finanzi, l-Ekonomija u Investiment qiegħed jagħmel l-emendi li ġejjin għall-Iskema.

IN accordance with section 7 of Government Notice No. 200, published in the Government Gazette dated 11th March, 2009, the Minister for Resources and Rural Affairs, after consultation with the Minister of Finance, the Economy and Investment is making the following amendments to the Scheme.

Minnufih wara l-paragrafu 2(iii), għandu jidhol dan il-paragrafu ġdid li ġej:

Immediately after paragraph 2(iii), there should be inserted the following new paragraph:

2 (iv) Minkejja għad-disposizzjoni tal-paragrafu 2 (ii), kull abitazzjoni domestika fejn ikun hemm iktar minn 10 persuni reġistrati, għandha tkun intitolata għan-numru ta' bozoz kif ġej:

2 (iv) Notwithstanding the provision of paragraph 2(ii), any household where there are more than 10 persons registered, shall be entitled to the number of lamps as follows:

Numru ta' persuni	Numru totali ta' bozoz	Number of persons	Total number of bulbs
11 – 20	20	11 – 20	20
21 – 30	30	21 – 30	30
31 – 40	40	31 – 40	40
41 – 50	50	41 – 50	50
51 – 60	60	51 – 60	60

Għall-fini ta' dan il-paragrafu biss, "persuna" tfisser residenti ta' Malta li, fl-20 ta' Ottubru, 2009, tkun reġistrata bħala individwu mal-Korporazzjoni tal-Enemalta għall-finijiet ta' hlas skont ir-Regolamenti dwar il-Provvista tal-Elettriku jew skont ir-Regolamenti dwar il-Fornitura tal-Ilma, tkun persuna li skont dawk ir-records li l-Korporazzjoni tas-Servizzi tal-Ilma jista' jkollha, tkun tgħix fil-bini, u "recipjent" tfisser kull persuna li tkun residenti ta' Malta u li hi detentrici skont l-Att dwar il-Karta tal-Identità (Kap. 258), u li tkun konsumatur skont ir-Regolamenti dwar il-Provvista tal-Elettriku jew skont ir-Regolamenti dwar il-Fornitura tal-Ilma u "dar" tfisser fond li għalih ikun qed jiġi mħallas l-elettriku jew l-ilma.

For the purpose of this paragraph only, "person" means a resident of Malta who, on the 20 October 2009, is registered as an individual with Enemalta Corporation for the purposes of billing in terms of the Electricity Supply Regulations or in terms of the Water Supply Regulations is a person who in accordance with such records as may be in the possession of the Water Services Corporation is residing in the tenement, and "recipient" means any person who is a resident of Malta and is a holder in terms of the Identity Card Act (Cap. 258), and is a consumer in terms of the Electricity Supply Regulations or the Water Supply Regulations and "house" means a premises for which electricity or water is billed.
